- Animal Control Contract-2018/2019 St. Hubert's

St. Hubert's submitted a two year contract for \$14,000 a year for animal control and wildlife services. The contract increased by \$3,600.00 from \$9,600.00 last year for the expansion of wildlife services this year. Dog license fees have increased for this year to offset the animal control services per Township Auditor recommendations. Comm.

Pfefferle would like to explore other options and other Animal Control Service providers. Township Administrator/Clerk Bobrowski advised the Board that there are a limited number of animal control services in the area to choose from.

Mayor Abraham made a motion, seconded by Chair Garay to approve the St. Hubert's Animal Control Contract for two years at \$14,000.00 a year.
