- **PARK EVENT/PROJECTS**
 - Volleyball Court - *Motion made, seconded and unanimously approved for \$185 payment to have sign installed at volleyball court.*
 - Girl Scout Gold awards- submitted to insurance for review
 - Jenna Quigley - dog waste station- we would like 4- \$50 each-
 - \$200 provided by Park & Rec.
 - Michele to pay for replacement bags from other Township funds.
 - Will be installed when weather permits. – *waiting on update*
 - Eagle Scout Project – Kevin Burns
 - memorial garden around flagpole with low maintenance shrubbery, bench and possible shade tree.
 - Kevin presented preliminary plan. Advised what is needed to proceed.
 - Doug Walker – 4 lean-to's to be donated and installed at park. Friends of Yards Creek Scout Reservation would be willing to donate the 4 shelters as well as pay for the moving costs associated with bringing them from YCSR to Alexandria Park if the town is willing to prep the sites for the shelters with the proper concrete piers.
